**HOCKEY PEI may revoke overage status at any time**

### Section 1 – PRE-REQUISITES FOR OBTAINING OVERAGE STATUS

- Limited skill**      Would mean: noticeable lack of basic hockey skill such as skating and balance for his/her age. Including limited aptitude for the game in the Pee Wee and higher divisions.
- Verification**      Would mean a letter(s) confirming the lack of skill and ability to play in the proper age division from the Association, Coach of respective team, including evaluation report if possible.
- Novice to Initiation**      - Discretion of Minor Hockey Association
- Atom to Novice**      - Player is of small and frail structure combined with limited skills  
- Beginner player (1<sup>st</sup> - 2<sup>nd</sup> year of hockey)  
- Health reasons – supported by letter from doctor
- Pee Wee to Atom**      - Player is of small and frail structure combined with limited skills  
- Beginner Player (1<sup>st</sup> - 2<sup>nd</sup> year of hockey)  
- Health reasons – supported by letter from doctor
- Bantam to Pee Wee**      - Player is of small and frail structure combined with limited skills  
- Beginner Player (1<sup>st</sup> year of hockey)  
- Health reasons – supported by letter from doctor
- Midget to Bantam**      - Player is of small and frail structure combined with limited skills  
- Beginner Player (1<sup>st</sup> year of hockey)  
- Health reasons – supported by letter from doctor



## **CRITERIA FOR HOCKEY PEI FINAL APPROVAL**

Final approval by the Minor Council is based on the following:

- 1 Approval from Parent - outlining reason
- 2 Endorsement/Approval by applicable Minor Hockey Association President
- 3 Approval by League Coordinator
- 4 Applicant meeting the Hockey PEI pre-requisites
- 5 Application form completed in full (Section 4)
- 6 Evaluation process completed by an independent evaluator (Section 3)

## **Exceptions**

Exceptions would be reviewed on an individual basis, in consultation with and approval of Minor Council Chairperson. Exceptions may be reviewed on an individual basis per criteria for Hockey PEI final approval.

## **Overage may not be approved for the following reasons:**

- Dislike of coach and team members
- Ice times
- Parents wish

**“Overage in a Division should be the Exception and not the Rule”**

## **Section 2 – CONDITIONS OF OVERAGE STATUS**

- All steps for approval by Hockey PEI must be followed and in writing.
- All approval for overage play is for games within PEI only. You must secure additional approval for any activity outside the Province of PEI.
- You must never play an overage player that has not been approved by Hockey PEI.
- Overage players can participate in Exhibition and League play.
- Overage players may play in Tournament games, but must receive approval from the Tournament Committee.
- All coaches are responsible to let teams that they are playing know they have an overage player. The overage player must be clearly marked on every game sheet (OA) beside the players' name.
- Overage status will be granted for one year only.
- Overage players are not eligible as affiliates to a higher Division or Category.
- Hockey PEI can revoke overage status at any time, when it has deemed that the actions of the overage player are not in the best interests of those affected by those



actions. If status is revoked, such player will have to return to their appropriate age division.

- Application acceptance critical date is December 1st.
- Final Approval for overage status must be obtained from Hockey PEI Minor Council.
- Exceptions must be reviewed in consultation with and approved by Minor Council Chairperson.
- Each application will be reviewed independently and carefully.

### **Section 3 – ON-ICE EVALUATION PROCESS**

A pre-requisite to obtain status to participate as an over-age player with Hockey PEI, each player must be evaluated (on-ice) by an independent evaluator of Hockey PEI. These evaluations will provide a recommendation to Minor Council on the ability of each applicant. This recommendation will be used by Minor Council in their decision to grant overage status.

Evaluations will be conducted during a game and/or practice with the appropriate age category team. The applicable Minor Hockey Association President can arrange a date for the evaluation with Hockey PEI.

Each application form must be accompanied by a **\$50 fee** for the evaluation process. No application will be reviewed without the applicable fee.
